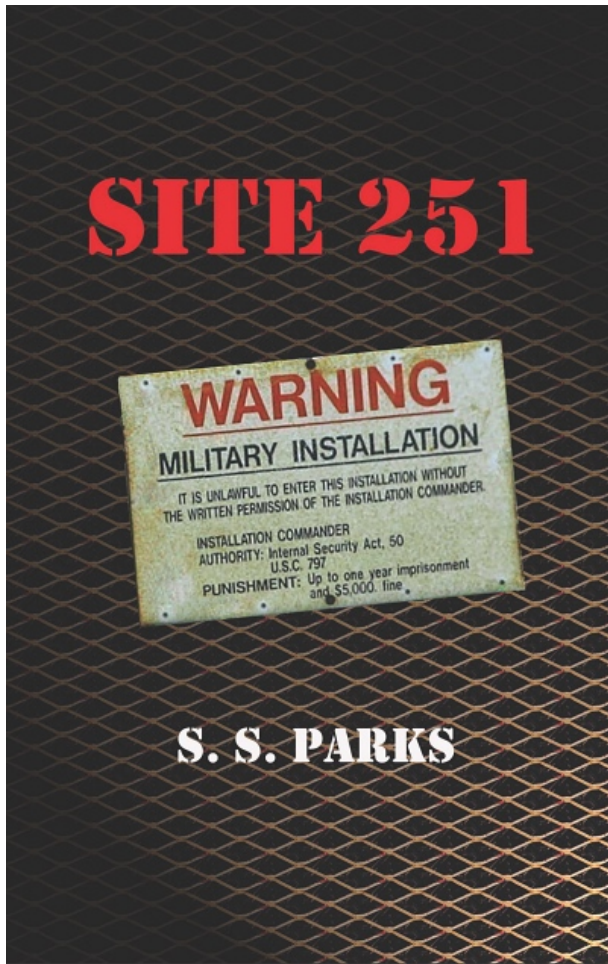
"No, that's at Nellis...It's...just call it Z51, Z as in Zebra."
