About the Author

Al Adaschik was born in New London, Connecticut, on June 27th, 1943. He was raised in Brooklyn, New York, and attended Franklin K. Lane High School. Upon graduation, he was accepted as an engineering student at the University of Michigan in its Naval ROTC program. After finishing college, Al qualified for Navy flight training and received his wings as a Jet Fighter Pilot in June of 1966. After completing his tour of duty, he left the service and earned an MBA from Long Island University at the C.W. Post Center in Greenvale, Long Island.

Al has worked as a Flight Test Conductor for the Grumman Aerospace Corporation, a Financial Analyst for the Singer Company, a Senior Financial Analyst for Pratt & Whitney Aircraft, a Financial Administrator for the City of Fort Lauderdale, and is presently retired from that position after twenty years of service.

Upon moving to Florida in 1976, Al and his first wife, Pam, opened and managed a School of Olympic Style gymnastics called The Gym, Inc., which was home of the Tumblebees (the girls' gymnastic team) and the Stingers (the boys' gymnastics team). The team colors were yellow and black. The phrase "Yea Buzz" was a common expletive heard around the gym anytime something good happened or a team member mastered a new trick. The Tumblebees, under the tutelage of Pam and Head Coach Tim Rand, rapidly became the most successful gymnastics team in the southeast United States, winning many honors and awards at both the State and Regional levels of competition.

Eventually, Al, in partnership with Dann Smith, capitalizing upon the success and reputation of the Tumblebees, began franchising Tumblebee mini-gyms in malls and shopping centers throughout South Florida. Nine locations were developed, and Dann and Al had visions of going nationwide with their concept. However, an undercapitalized situation, combined with the launching of a disastrous "Gym-On-Wheels" venture, drove the Tumblebees into bankruptcy.

When hired by the City of Fort Lauderdale, Al was on a fast track to become Director of the city's Utilities Department. However, his career came to a screeching halt three years after being hired when he discovered that his department was dumping raw sewage into the river which ran through downtown. Not able to accept this state of affairs, after attempting to solve the problem internal to the city, Al enlisted the help of a friend and neighbor. Their involvement brought about an end to the problem.

Despite the difficulties Al experienced with his superiors subsequent to the pollution incident, his contributions did not go unrecognized. On March 1, 1988, the Riverside Park Residents Association honored him with a plaque that read, "In profound appreciation of your many contributions to our community. We acknowledge your dedication, wisdom, generosity, and reliability, which has been a foundation of our neighborhood's progress and which have made Riverside Park a better place to live." On November 2, 2001, the day Al retired, the Mayor and City Commission officially decreed that day to be "AL ADASCHIK Day." This honor was offered in appreciation for the dedication, professionalism, and leadership he has exhibited throughout his career as a public servant.

In 1994, Congress passed the General Agreement on Tariffs and Trade (GATT), making the United States a member of the World Trade Organization (WTO). According to the Fort Lauderdale news, this Act was passed by pushing sovereignty issues aside. This revelation motivated Al to obtain a copy of the GATT Accord from the Government Printing Office, and this document revealed that our membership in the WTO required that this nation subordinate the prerogatives of our President, Congress, and the Supreme Court to the WTO's Ruling Panels. This being the case, acting as Attorney Pro-se for the citizens of this nation, Al sued our Federal Government in the Federal District Court of Miami over the constitutionality of GATT and our membership in the WTO.

Subsequent to Al's lawsuit against the Federal Government over the constitutionality of GATT, Al wrote a book, available free online, entitled "While We Sleep – A story of government without law". This

book begins with a narrative about Al's idyllic childhood, describes the circumstances of his bringing a halt to the pollution of Fort Lauderdale's New River, documents Al's efforts to jumpstart his stalled career, and concludes with a description of how Al worked to undo the harm done to this nation by the passage of the GATT accord and our resulting membership in the World Trade Organization.

Finally, Al developed and hosted a website called "The Constitution Forum", in the hope of waking people up to the plight this nation is in. As host of this website, he authored a plethora of political tracts and articles, many of which can be found online under his name.

Chapter 1: The Overthrow of Our Government

The first event we will discuss is the granddaddy of them all, *the overthrow of our government*. Unlike other events in this book, this one will be proven to be true. Of course, you are free to believe as you wish, but an overthrow did take place. Any intelligent person who is honest with himself will agree with this conclusion. People tend to hear what they want to hear and believe what they want to believe. To be sure, no American wants to believe we live in a nation ruled by conspirators who overthrew our government. However, wishful thinking is not a sound basis for what we believe. Understanding this, if you are going to profit from reading this book, you must give credence to the possibility that our government was overthrown and not dismiss any idea out of hand just because it is repugnant.

The United States of America is supposed to be a constitutional republic. This is easy to say, but what do these words mean? A *republic* is a form of government where all authority is exercised by the people through their elected representatives. A *constitutional republic* is a government where this state of affairs is formerly established by a written constitution. A *constitution* is an expression of the will of the people, and it defines the nature of the government they agree to live under. From a citizen's perspective, it is a contract between citizens that contains the laws and rules that control their agreed-upon government. The government in question had nothing to do with creating its constitution. Instead, it is a document created by citizens and imposed upon the government. The constitution, once established, is the wellspring of all other laws, rules, and regulations that govern a nation and its citizens.

Understanding all the above, it is obvious that the government bequeathed us by the Founders was a constitutional republic. The word *was* is used in this last sentence because it should also be obvious that this is no longer true. Our present government pays lip service to our

Constitution and routinely ignores its most important provisions.¹ Furthermore, when government officials refer to this nation, they call us a *democracy* and never describe us as being a constitutional republic. This is not an oversight! Government officials know full well they no longer respect the provisions of our Constitution, so they call us a democracy, hoping that knowledge of our constitutional roots fade into oblivion. As citizens, we are no longer supposed to think *constitution*. Instead, we are continually reminded to think *democracy*. This is done so those who rule us will be free of our Constitution's constraints and limitations. With our Constitution neutered and forgotten, their goal has been realized.

If our government is no longer a constitutional republic, it is reasonable to conclude that somewhere along the way, a change took place. The key question is whether this change happened gradually over time or suddenly at one point in our history. The answer to this question is important. If our government changed gradually over time, it is reasonable to assume that nothing criminal or underhanded occurred. However, if the change occurred suddenly at one point in our history, then the implications are that the changes were the result of a plan. If a deliberate plan was behind how our government changed and this plan was implemented without our knowledge or consent, then it follows that our government was overthrown. A hallmark of the American experiment in democracy is that our government rules by the consent of the governed. If major changes to how our government functions are made through stealth and subterfuge, then the government we are left with does not enjoy our consent and is not legitimate.

Unfortunately, the facts are clear. The evidence supports the conclusion that the government we have today is not the outcome of gradual changes that took place over time. Instead, it is the handiwork of a group of conspirators who met in secret to plot our government's demise. This was done so they would enjoy a government easier to control and better suited to their self-serving purposes. Who are these people? One name we call them is the Federal Reserve Bank or Fed,

but they also call themselves the New World Order. This name is deceptive because the so-called New World Order is really the *old-world order* with an upscale name. Whatever they call themselves, they are the rich and powerful old-line banking families who have pulled the strings that made the world dance through the centuries. Their plot was brought to fruition concurrent with the passage of the Federal Reserve Act in 1913. Most Americans think the Federal Reserve Act was a legitimate act of Congress. Nothing could be further from the truth.

In order to establish that our government was overthrown, four elements of this crime must be demonstrated to be true. These elements are as follows:

- Identification of a group of conspirators.
- Establishment of the groups willful intent to commit the crime.
- Identification of actions taken to consummate the crime.
- Identification of what changed as a result of the actions taken.

Before proceeding, it should be understood that the Federal Reserve Act is unconstitutional. Article 1, section 8 of our Constitution states that Congress shall have the power “to coin money and regulate the value thereof.” This power is not so much a power but instead a responsibility of Congress. Nowhere in our Constitution is authority given to defer, subordinate, or transfer this responsibility to someone else, especially to a foreign banking cartel. The Federal Reserve Act is unconstitutional because it stands in flagrant violation of Article 1, Section 8 of our Constitution, but more so when one realizes the tremendous authority and power Congress wrongfully handed over to a group of private bankers.

These men were voted the right to create our money with the stroke of a pen and then loan it back to us at interest. The problem is, upon doing so, the American people are on the hook to pay back the amount borrowed plus interest, with money not created out of thin air, but money earned through industry and hard work. What do Americans get for toiling to make these men rich beyond anyone’s wildest dreams?

Nothing! We get absolutely nothing but recessions, depressions, inflation, war, destruction, suffering, mayhem, and death!

At this point, it should be clear that we have identified our group of conspirators, and from this point forward we will call them Banksters. This name works well because they are an international banking cartel that owns most of the central banks of the world. In any case, in 1910, representatives of these Banksters met secretly at Jekyll Island, Georgia,² to map out a strategy to hoodwink Congress into passing the Federal Reserve Act. This act of Congress made the Banksters' foreign banking cartel the Central Bank of the United States. As terrible and wrongful as this development is, taken at face value, it does not constitute a willful intent to commit a crime.

However, if one understands what really happened, the criminal nature of these doings becomes apparent. Mayer Amschel Rothschild, who was one of the most influential and powerful bankers of all time, said, "Permit me to issue and control the money of a nation and I care not who makes its laws". The legislative process, without question, is a prime function of government. If, as Mr. Rothschild explained, this prime function is trumped or overshadowed by those who issue and control money, then it follows that the Jekyll Island conspirators knew that by obtaining control of our money supply, they would also be taking control of our government.

It is one thing for a special interest group to induce Congress to pass legislation that will be of benefit to them. It is quite another thing to cajole, bribe, and hoodwink Congress into passing legislation that changes the nature and form of our government. Unfortunately, this is what happened. The Jekyll Island conspirators knew that passage of the Federal Reserve Act meant they would have the power to dominate and control our government. To argue, these men met in secret for some other purpose beneficial to the American people is ridiculous. Taking control in the manner and for the reasons they did was solely to their benefit and to the detriment of the American people. Thus, the conspirator's willful intent to commit a crime has been demonstrated.

In all likelihood, you are still not convinced that an overthrow of our government occurred. If all that happened in 1913 was the passage of the Federal Reserve Act, I would agree with you. However, the plot was far more extensive than a simple passage of an act of Congress. In 1913, Amendment XVI was also ratified.³ The intent of this amendment was to create a new source of revenue by legalizing a tax on the wages earned by American workers. Prior to 1913, our government obtained all the money it needed from duties, tariffs, and other charges for services. A tax on the wages of working Americans is prohibited by article 1, section 9, clause 4, of our Constitution. This Clause provides that Congress cannot levy a direct tax on individual citizens. However, the Banksters knew that a new and significant revenue source would be needed to pay for the soon-to-be rapidly growing national debt. They also wanted to ensure that they owned a measure of every working American's time and labor. Therefore, they took steps to get this wrongful and misplaced power through the ratification of Amendment XVI. However, despite all their efforts and the strings they pulled to ensure its ratification, they never anticipated that the Supreme Court would throw a monkey wrench into their plans by ruling that Amendment XVI did not accomplish its intended purpose.

The Banksters believed the wording of Amendment XVI provided them with a new source of revenue: a direct tax on the earnings of every working American. However, in the case of *Stanton v. Baltic*,⁴ the Supreme Court ruled that a tax on the income of working Americans was unconstitutional. This ruling applied to Amendment XVI, and as a result, a tax on the wages of working Americans remained unconstitutional. The Court reasoned that income referred only to returns from investments and profits realized by businesses. Wages paid to American workers, according to the Court, are not income. Instead, wages are a simple exchange of money for a person's time and labor. Such an exchange is akin to bartering or the exchange of things

of equal value between people. No income is involved or derived from such an exchange. This ruling meant that the Banksters failed to constitutionally create the new revenue source they coveted. However, this setback presented no problem for them, and what happened next demonstrates that these doings are a step in a well-thought-out plan.

The Bankster simply ignored the Supreme Court ruling and implemented a tax on wages anyway, even though it was not constitutional. Today, we dutifully pay our income taxes without realizing that paying them is not constitutionally required. There is no basis for paying a tax on earnings under constitutional law. Taking this a step further, it can reasonably be argued that when our government insists, we obey the law and pay our income taxes, it is guilty of fraud. Furthermore, if our government takes us to court and forces us to pay income taxes, it is guilty of robbery. If this state of affairs doesn't demonstrate the wrongful and misplaced power handed to the Banksters by Congress through the Federal Reserve Act, then nothing does. From 1913 forward, our newly created government was above the law and could ignore our Supreme Court when necessary. In case one fails to see the significance of this, it means that our Supreme Court is no longer supreme.

Amendment XVII⁵ was also added to our Constitution in 1913, and this amendment provided for the direct election of senators by citizens instead of being appointed by state legislators as the founders intended. The founding fathers must have made a mistake when they decided on this matter. Amendment XVII is a wonderful step forward for democracy. Upon ratification, *we the people* had the right to vote for all our representatives in Congress instead of just those in the House of Representatives. Unfortunately, while this development appears to be beneficial, nothing is further from the truth. Instead, ratification of Amendment XVII was a diabolical step that completed the ignoble transformation of our government.

Prior to the ratification of Amendment XVII, the federal government was a federation of state governments. In keeping with

this, the states exercised control over the federal government by appointing two representatives to the United States Senate. The Senate is the superior arm of Congress and serves as a check on the powers of the President. By changing this arrangement, the Banksters eliminated a crucial check and balance of our Constitution. However, far worse is that this also changed the fundamental nature of our government. Upon ratification of Amendment XVII, our federal government was no longer a federation of states answerable to the state legislatures. Instead, it became an all-powerful national government, superior to and dominant over our state governments.

At this point, we have identified three major changes, all of which occurred in 1913, and were specifically designed to change the nature and form of our government. Furthermore, when these changes were implemented, most people had no clue as to what they really entailed. In other words, the nation was hoodwinked into accepting these changes. This is not the way such things are supposed to be done. Informed consent means that we the people are apprised of the implications or end results of what our government is trying to accomplish through legislation or the amendment process. In 1913, neither our government nor the media informed us about what was really being done to us.

To summarize, the Federal Reserve Act gave the Banksters control of our monetary system. This gave them enormous wealth, which enabled them to control and corrupt our government as well as other key institutions of our society. Amendment XVI was supposed to create a new revenue source by taxing the wages of American workers. When Amendment XVI failed to accomplish its intended purpose, the Banksters implemented an unconstitutional tax on wages anyway. Finally, Amendment XVII was added to our constitution, which severed the control the states had over our federal government. The coup was complete! The Banksters were in control, and we were a subjugated people. A summary of these changes follows:

Before 1913

- Our federal government obeyed the law and our Constitution.
- Our federal government was a federation of state governments and was limited in scope and power.
- Senators were appointed by state governments.
- The Supreme Court was supreme.
- Congress created our money and regulated its value.
- State governments had a measure of control over our federal government.
- No tax on income or wages was necessary.
- Americans were free to keep and enjoy the fruits of their labor.

After 1913

- Our federal government became a national government with unlimited power.
- Our Constitution was rendered dysfunctional and nonbinding upon our new national government.
- State governments no longer had any way of controlling our new national government and were subordinate to it.
- The Supreme Court was no longer supreme.
- The Fed controlled our money supply and regulated its value.
- An unconstitutional income tax on the wages of American workers was established.
- Senators were elected to office by popular vote.

In conclusion, in 1910, a group of conspirators met on Jekyll Island to plan an across-the-board takeover of our government. The nature of this takeover was complex and far-reaching. It changed Americans from being free and independent people into being the economic slaves of the Banksters. There may be many of us still reluctant to acknowledge the validity of these astounding conclusions. Fortunately, we have a high-level government official who will help us surmount

this hurdle. President Woodrow Wilson was our president in 1913, and he championed the passage of the Federal Reserve Act. However, President Wilson was a man with a conscience. In his waning years, he came to realize the terrible mistake he had made and the horrible consequences of his mistake. To salve his conscience, he issued the following statement:

I am a most unhappy man. I have unwittingly ruined my country. A great industrial nation is now controlled by its system of credit. We are no longer a government by free opinion, no longer a government by conviction and the vote of the majority, but a government by the opinion and duress of a small group of dominant men.

President Wilson was not an ignorant man, nor was he delusional when he wrote the above words. He knew exactly what he was talking about. The passage of the Federal Reserve Act in 1913 meant the American people were no longer masters of their own fate. Instead, a group of super-rich bankers would call the shots and pull the strings that made us dance. The great irony in this is that the wealth we are talking about came from us. The Banksters did nothing to earn this money and had no justification for keeping it. However, keep it they did because Congress foolishly and wrongfully voted to allow them to do so.

Chapter 4: The HMS *Lusitania* Incident

The United States never should have entered WWI because we had nothing to gain by fighting this war. However, having made a decision to go to war, we opted to fight for England, the aggressor nation, instead of Germany, the nation that wanted peace. In the October 13, 1972, issue of *Life* magazine, there appears a feature article by Colin Simpson, a British journalist, entitled “*LUSITANIA: New evidence on the ‘unprovoked’ sinking that dragged us toward war.*”¹⁴ This article supports the above conclusion. For thirty years, our government purposely withheld vital information about the sinking of the *Lusitania*. This act of omission led people to wrongfully believe that the *Lusitania* was an innocent passenger vessel carrying innocent cargo. She was not! Because of these erroneous impressions, Americans viewed the sinking of the *Lusitania* as an unprovoked and unjustified act of war against the citizens of the United States.

According to Colin Simpson, The British Admiralty financed the construction of the HMS *Lusitania* and as a result, the ship was fitted with twelve 6-inch guns. Also, in times of war, the ship would serve as an armed auxiliary cruiser under the command of the British Admiralty (navy). Cruiser rules, subscribed to at the time by maritime nations, specified that unarmed merchant vessels would be warned before being sunk; thus, allowing the crew time to abandon ship.

Because the *Lusitania* was an armed vessel, these cruiser rules did not apply, and legally, she sailed under the rules of war. From October 1914 onward, the British Admiralty made it an offense for British merchant ships to obey a German U-boat’s order to halt. They were under strict orders to use their weapons to sink an approaching U-boat. If no weapons were available, then they should make every effort to ram the submarine. This meant that U-boats could no longer safely

make surface attacks. As a result, the possibility of mistakenly sinking vessels of neutral nations was increased. To aggravate this situation further, the Admiralty ordered British ships to paint over their names and port of registry as well as to fly the flag of a neutral nation.

In retaliation for Germany's mining the entranceways to British ports in the North Sea, England mined wide areas of open sea lanes in the North Sea and declared the entire area to be a war zone. Germany soon followed suit and followed up with a declaration to the neutral powers, which said that due to British misuse of neutrality rules, no vessel was safe from attack in the North Sea and that neutral vessels and citizens should avoid the area.

President Woodrow Wilson declined to pass this warning on to American citizens and responded to it by informing Germany that despite the circumstances, any sinking of an American ship or the loss of American lives on any foreign vessel would be considered an indefensible violation of America's neutrality rights. This message shocked the Germans because they had no way of knowing if Americans were present on any of the targets they encountered. Understandably, the British greeted President Wilson's message with jubilation.

On March 28, 1915, at the approach to the English Channel, German submarine *U-28* commanded the HMS *Falaba* to halt by firing across her bow. She refused, but eventually was forced to heave to, and her crew was ordered to abandon ship. The *Falaba's* crew stalled for time, and secretly sent a wireless message for help. As result, an armed British trawler appeared on the horizon. With this development, the *U-28* fired a torpedo into the stern of the *Falaba*, setting off the thirteen tons of explosives she was carrying. Among those killed was Leon C. Thresher, an American citizen. The American press reacted with unbounded fury to this incident despite the fact that cruiser rules were properly followed, and the crew of the *U-28* had no knowledge of an American being on board. An American was killed and the circumstances of how did not matter.

On her ill-fated return voyage to England, the *Lusitania's* cargo was primarily contraband: 1,639 ingot bars of copper, 1,248 cases of three-

inch shells, 76 cases of brass rods, and 4,927 boxes of cartridges, each containing 1,000 rounds of ammunition. The weight of all these high explosives was 10½ tons. It was common knowledge that carrying such cargo was a routine undertaking for the *Lusitania*. Because of the increasingly volatile situation, George Vierick, a representative of the New York German community, attempted to place ads in fifty American newspapers, warning Americans about the risk of embarking on a transatlantic voyage to England. In response, the State Department advised the newspapers that it would be highly dangerous to run the ad, so none did. Eventually, Mr. Vierick convinced the editor of the *New-York Tribune* to run his ad, which the *Tribune* did on the morning the *Lusitania* sailed. Apparently, no American sailing on the *Lusitania* elected to change their plans at this late point in time.

The *Lusitania* set sail on its final voyage shortly before noon on May 1, 1915. Her master, Captain William Turner, was under orders to steer the same course used on previous journeys. This known course would take the *Lusitania* south of Ireland, where she would be met by the British cruiser *Juno*. The *Juno* was under orders to escort the *Lusitania* for the rest of her journey. At this point in time, the *U-20* was patrolling the waters south of Ireland where the *Lusitania* was heading. By monitoring transmissions, the British Admiralty was able to pinpoint the locations of the *Juno*, *Lusitania*, and the *U-20*. By plotting these positions, it was apparent that if the *U-20* stayed where she was, the *Lusitania* would run into her the next morning. However, the *U-20* was not content to just sit and wait for the *Lusitania*. The afternoon before their meeting, the *U-20* sank both the HMS *Candidate* and HMS *Centurion*. There was no response from the British to these two tragic losses.

Normally, destroyer escorts are dispatched by the British Admiralty to the seas south of Ireland at the first hint of a U-boat's presence. Not this time! In light of this enemy action, Admiral Coke of the British Admiralty wanted to send a message to the *Lusitania* to warn them of the looming danger. He was ordered not to. Having a conscience, Admiral Coke disobeyed orders and sent his message anyway, which was picked up by the *Lusitania*. However, Captain Turner decided not

to heed the warning because he felt his scheduled rendezvous with the cruiser *Juno* would be sufficient protection for his ship. Furthermore, he was sailing under Admiralty's authority and could not change course without getting permission. Meanwhile, back at Admiralty headquarters, Admiral Oliver advised Winston Churchill that the *Juno* was unsuited for protecting the *Lusitania* and was also at risk of being sunk. This being the case, he recommended that elements of a nearby destroyer flotilla be dispatched to protect the *Lusitania*. What happened next is told in Colin Simpson's own words:

At this juncture, the Admiralty War Diary stops short, perhaps understandably as it was here that the decision was taken that was to be the direct cause of the disaster. No one alive today knows who took it, but shortly after noon on May 5, the Admiralty signaled *Juno* to abandon her mission and return to Queenstown. They did not dispatch any destroyers and the *Lusitania* was not informed that she was now alone, and closing every minute with the U-20.

The rest is history! A German submarine, the *U-20*, sank an innocent passenger vessel, killing 1,198 people, 123 of which were Americans. Obviously, the Germans are the bad guys, and to get even with them, this nation spent \$22 billion and sacrificed the lives of 137,000 of our finest young men and women.

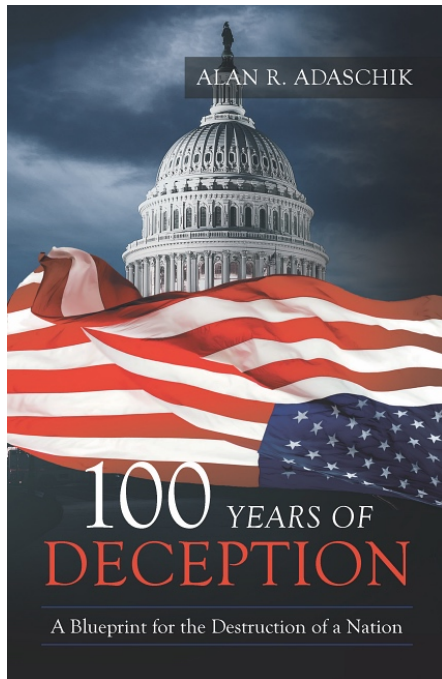
Who is to blame for the sinking of the HMS *Lusitania*? To be sure, the Germans loaded the gun and pulled the trigger. However, in contrast to what we have been told by our government, the Germans were justified in committing what was a legitimate act of war. On the other hand, it was the British Admiralty that made the HMS *Lusitania* a target by

- arming her with deck guns and loading her with munitions.
- insisting she maintains a course known to the Germans.
- removing an escort vessel that may have saved her.

- failing to provide readily available destroyer escorts.
- refusing to warn her of the impending danger.
- not ordering her to take a course north of Ireland instead of going south, where it was known that a German U-boat lay in wait for her arrival.

England wanted the United States to enter the war on her side. Toward this end, the British Admiralty set up the HMS *Lusitania* and two thousand people to be torpedo fodder for a German U-boat. But what was *our* government's role in this sordid affair? The Zionists had a special interest to see as many Americans as possible sail on the *Lusitania*. The more Americans killed the louder Americans would scream for German blood. Could this be the reason why President Wilson failed to warn Americans to not sail on Allied ships heading into a war zone? Is this also why our State Department discouraged newspapers from running ads about the danger of sailing on British vessels? What other reasons are there for government officials to remain silent while Americans foolishly placed their lives in grave danger?

Are we really to believe that the governments of the United States and England would deliberately sacrifice the lives of thousands of innocent men, women, and children just to give the United States an excuse to go to war? Winston Churchill, in *The World Crisis*, his autobiography, said, "At the summit, true politics and strategy are one. The maneuver which brings an ally into the field is as serviceable as that which wins a great battle."
