Chapter One: The Laws of Physics

A mechanical engineer, this author can tell you with absolute certainty: 1) A balloon cannot spontaneously inflate itself; 2) A ball cannot spontaneously roll uphill; and, 3) Temperature cannot spontaneously increase above surrounding, or ambient temperature. The author is certain you'd agree. These statements involve path, pressure and temperature and simply state the hard realities involved in the "Second Law of Thermodynamics."

Sir Isaac Newton, perhaps, the most intelligent scientist who ever lived, foundationally discovered and began to define the fundamental Laws of Physics with his mathematical proofs deriving the Calculus, both, differential and integral, also proving the inverse relationship between the two. Newton did extensive work developing experiments in optics, mechanics (Newton's Laws of Motion), chemistry, theology also extensively studying Bible prophecy, the occult, alchemy and other areas of interest. He lectured at Cambridge for about thirty years and is considered by many to be the most influential scientist and mathematician in history.

Second Law Stated: *"It is impossible for any system to operate in such a way that the sole result would be an energy transfer by heat from a cooler to a hotter body."* Taken from Fundamentals of Engineering Thermodynamics (Second Edition) by Michael J. Moran, Howard J. Shapiro, Copyright 1998, 1992 by John Wiley and Sons. This is among the LAWS of Physics. It is called THE SECOND LAW,

because the law cannot be breached, it is ALWAYS TRUE. PERIOD!
IT'S THE LAW.

Impossible! Direction is the key and only proceeds spontaneously from higher to lower energy states, i.e. Heat Transfer from hot to cool, never cool to hot (check your AC Bill) and this means things in the Universe are always proceeding from higher states of organization to lower states of organization, never in the opposite direction, unless someone blows up the balloon, moves the ball up the hill or lights the fire. Isaiah was a politically astute and well educated prophet, who spoke and wrote in Jerusalem between 745 B.C. and 680 B.C. Isaiah called Israel's northern kingdom, of which Samaria was the capitol, to repentance. However, they, as Judah (southern kingdom) also later, refused to listen. Isaiah 46: 8-13:

“Remember this, fix it in your mind, take it to heart you rebels. Remember the former things, those of long ago; I am God, and there is no other; I am God and there is none like me. I make known the end from the beginning, from ancient times, what is still to come. I say: My purpose will stand and I will do all that I please. From the east I summon a bird of prey; from a far off land, a man to fulfill my purpose. What I have said, that will I bring about; what I have planned, that will I do. Listen to me you stubborn hearted, you who are far from righteousness. I am bringing my righteousness near, it is not far away; and my salvation will not be delayed. I will grant salvation to Zion, my splendor to Israel.” (NIV) (emphasis added)

Is this challenge true? Does the God of Abraham, Isaac and Jacob tell us the “end from the beginning” and “from ancient times what is still to come?” This boast of the Lord is clear to be discerned, as absolutely true, or not, by human beings. As coherent Communication, from the creator of humans and the Universe if true or nonsense! Hmmm? He made the boast as a challenge. The Lord was making monkeys of brilliant atheists, and professors with human cooked up and kooked out and outrageous non-realities and logically non-connected theories beginning long ago and he scoffs at them in his own words. Letting God, of the Bible, who boasts himself, “I make known the end from the beginning, from ancient times, what is still to come” “... “Ancient times, what is still to come?” (NIV) speak for himself, speaks for itself. If we consider Isaiah and the boast of God, then we should look to these ancient times to see if God's bucket holds water through history or the Hebrew Scriptures, are a mere human book (many books) of empty boasts, invented by men, as only those who have not investigated and examined the evidence can ignorantly and illogically claim. Indicates lazy mindedness and a basic lack of foundation of intelligence, or even inquisitive minds, where ignorance (Ignorance: "The Science of Ignoring the Facts." Snickering.) without any investigation the blind ignorance is stated by the ignorant roosters, as though it is fact. Chapter Three: The Angels Speak

Daniel in Chapter 8: 13, 14 recounts what the two angels in his vision state:

“Then I heard a holy one speaking, and another holy one said to him, “How long will it take for the vision to be fulfilled—the vision concerning the daily sacrifice, the rebellion that causes desolation, the surrender of the sanctuary and the trampling underfoot of the Lord’s people?”

14 He said to me, “It will take 2,300 evenings and mornings; then the sanctuary will be reconsecrated.”
(NIV) (Circa 1972)

Slightly mistranslated, the author will show, in the KJV here:

“Then I heard one saint speaking, and another saint said unto that certain saint which spake, How long shall be the vision concerning the daily sacrifice, and the transgression of desolation, to give both the sanctuary and the host to be trodden under foot?

14 And he said unto me, Unto two thousand and three hundred days; then shall the sanctuary be cleansed.” (King James Version (KJV)) (Circa 1611)

Daniel had seen a ram and a shaggy goat at war in his vision and the angel then reveals to Daniel the ram is the Medo-Persian Empire and the shaggy goat is the King of Greece. In 334 B.C. Alexander the Great attacked Darius’ forces at the River Granicus as also chronicled in separate extra-Biblical (i.e. secular) historical accounts. (Google it) The peculiar term “2300 evenings and mornings” was mis-translated or misinterpreted slightly in the KJV as 2,300 days. But the near prophetic fulfillment was Antiochus Epiphanes who indeed stopped the sacrifices in the Jewish Temple and banned all worship among the

Jews, also sacrificing pigs in the temple and in the cities and villages of Israel. NOTE: Usually there is a near prophetic event establishing the words of the prophet as accurate, then a distant prophetic event stated concerning the Lord's ultimate purpose in the prophecy.

The angel also informed Daniel in chapter and verses at 8: 17-21:

“So he came near where I stood: and when he came, I was afraid, and fell upon my face: but he said unto me, Understand, O son of man: for at the time of the end shall be the vision.

18 Now as he was speaking with me, I was in a deep sleep on my face toward the ground: but he touched me, and set me upright.

19 And he said, Behold, I will make thee know what shall be in the last end of the indignation: for at the time appointed the end shall be.”

20 The ram which thou sawest having two horns are the kings of Media and Persia.

21 And the rough goat is the king of Grecia: and the great horn that is between his eyes is the first king.
(KJV)

The angel goes on to explain after the kingdom of the Greeks in Asia (Alexander the Great) his kingdom would be divided into four and the fierce man of intrigue (Epiphanes) would rise and become very powerful to overcome the Jews and accomplish his blasphemous reign until his own death.

The angel speaks also to the time of the end. “The distant future.” So there was a distant time of the end prophetic meaning also. The term “evening mornings” was used in regard to Passover, the evening before the Children of Abraham, Isaac and Israel left Egypt, then the actual exit in the morning after the death of all firstborn males in Egypt the Jews spared per the blood on their doorposts. (See: Exodus Chapter 12).

Passover had already been celebrated in 334 B.C. by the time Alexander attacked and defeated the Medo-Persians in the first event, historic Battle of Granicus, in Daniel's recording and the angels' foretelling of the future to the Prophet Daniel. Counting forward 2300 Passovers, remembering there is no year zero (B.C. to A.D. or B.C.E. to C.E., if you like) 2300 Annual Passover Holiday(s) later Israeli Paratroopers retook the temple mount in Jerusalem on June 7, 1967 an event witnessed by the author then aged nine, as the angel of the Lord accurately and specifically predicted over 2500 years prior. The Lord himself, mocks these critics and atheist professors. The math: $-334 \text{ B.C.} + 1 \text{ (year 0)} + 2300 = 1967 \text{ A.D.}$ The predicted fulfillment of Daniel 8: 13, 14.

From gotquestions.org the following succinctly explains the time designation issue:

“In recent times, there has been a push to replace the B.C. and A.D. labels with B.C.E and C.E., meaning “before common era” and “common era,” respectively. The change is simply one of semantics—that is, AD 100 is the same as 100 CE; all that changes is the label. The advocates of the switch from BC/AD to BCE/CE say that the newer designations are better in that they are devoid of religious connotation and thus prevent offending other cultures and religions that may not see Jesus as “Lord.” The irony, of course, is that what distinguishes B.C.E from C.E. is still the life and times of Jesus Christ.”

The skeptics of Daniel have claimed all along Daniel's writings had to be after the fact as they were far too accurate in historical terms to have been written before the events. The Dead Sea Scrolls were discovered in jars in 1947 (year before Israel was reborn as a modern nation ... No COINCIDENCE) and these date to 200 B.C. and included copies of Daniel. Antiochus Epiphanes reigned, after that date, in history, from 175 B.C. to 164 B.C. when he died.

By 200 B.C. those who buried the Scrolls in the jars already considered Daniel's words authentically prophetic and we see events happening today (1967) foretold there also. The skeptics have been tin canned by the Lord God and his angels in the Prophet Daniel's

writings. NOTE: To the reader, articles on the Dead Sea Scrolls, Alexander, The Battle of Granicus, Antiochus Epiphanes and the four original Seleucid Kings and the retaking of Jerusalem by the Jews in 1967, are available on line and in libraries for more background into these matters.
